The Mother Superior House is located on the corner of Main and Granary Streets next to Harmonist Community House No. 2. The Log portion of the house is an original Harmonist log cabin. The brick portion of the house was added when Community House No. 2 was constructed. It was used as the dormitory kitchen during the Harmonist period and as a tavern during the Owen/Maclure era. Paul Tillich spent a brief period in this house in the early 1960s as Jane Owen's guest. The house was named after Mother Ruth, an Anglican nun and one of Jane Blaffer Owen's spiritual mentors. The guest house is primarily reserved for short-term use by artists, writers and scholars.

**RATES FOR USE OF PROPERTY** subject to 5% County Innkeepers' tax and 7% Indiana sales tax.

### **HOUSE RULES**

No unregistered guests.

Do not rearrange the furniture.

No parties or events without prior permission from property manager.

Eating or drinking in bedrooms should be restricted to tea, coffee and light snacks.

Please turn off lights when away, except for interior lamp and exterior wayfinding lights.

Turn down AC/heating when away.

Please use coasters under beverage containers.

Report any breakage or problems with plumbing, electrical, or heating/AC to Management.

Do not put anything in the toilet(s) other than toilet paper and your "business."

Wash dishes as you use them and keep food in containers. Leaving food out may attract rodents.

Abide by agreed-upon check-in and check-out times.

If you need additional time, please contact the property manager.

Please keep track of the house key. A \$25 fee will be charged for replacement.
